## **Plot Summary**

"Gone Girl" is a novel by author Gillian Flynn. The story follows a married couple, Nick Dunne and Amy Elliott Dunne, from the time they meet and up until Amy goes missing under suspicious circumstances. Amy Elliott Dunne and Nick Dunne are both writers by trade, but when they both lose their jobs, and Nick's mother falls ill with cancer, Nick and Amy move back to Nick's hometown of Carthage, Missouri.

As a New York City girl, Amy is not a proponent of the move. Nick borrows some money from Amy's take on her parents' book series, Amazing Amy, to open The Bar with his twin sister Go. With their marriage failing, Nick starts an affair with one of his college journalism students. One day while Nick is at The Bar, his neighbor calls to say the front door to Nick's house is open and the inside cat is outside. Nick arrives home to find the living room ransacked and his wife missing.

As the investigation proceeds, all clues point to Nick as the primary suspect. After being gone for a little over a month, Amy shows up at Nick's door, claiming one of her former stalkers kidnapped and raped her. Amy, Nick and even the detectives know that Amy was trying to frame Nick for her murder. The problem is that nobody can prove it.

Amy continues to act on a new plan once she returns to Nick. This time, it involves getting pregnant and urging Nick to drop the investigation against her. While this works for some time, right before Amy goes into labor, Nick makes a statement to Amy that just might be enough to set her off on new direction—one where she tries to take Nick down once again.

## **Nick Dunne: The Day of Pages 1-15 Summary**

Nick says what he remembers about his wife is the shape of her head.

He then seems to go back in time. He talks about waking up at 6 am one morning and he can hear the sounds of his wife Amy making breakfast downstairs in the kitchen. He also talks about how he was a writer in New York City, but that when he lost his job, he moved them to his hometown of Carthage, Missouri. He says his twin sister, Margo, which he calls Go, moved back just prior to him and Amy moving there. Go moved back when their ailing mother was dying and because she also lost her job.

Go and Nick borrow \$80,000 from Amy, the last of her trust fund, to open a bar in town called The Bar. It is connected to the bowling alley so they can always hear the sounds of bowling.

When Nick goes back in time to tell the story, it is presumable the day that his wife goes missing or is found dead. Nick describing how much Amy didn't want to move to Missouri and how much she didn't want to buy the pretentious house they buy is Nick's guilt talking. Now that something has happened to Amy, he feels like it is all his fault that she was here in the first place.



# **Amy Elliott: January 8, 2005**

#### **Amy Elliott: January 8, 2005 Summary**

Amy Elliott is writing in her diary. She is talking about a great guy that she met at her friend Carmen's party. Amy is also a writer, but she writes questions for personality quizzes. Amy confirms that the guy's name is Nick. She also says he's gorgeous. They chat about his boyhood home and Nick continues to make movie references throughout their conversation.

Nick and Amy also share a cab home. even though it is 1 am, they hit a traffic jam so decide to walk the rest of the way. A bakery is receiving a delivery so powdered sugar is billowing in the air as Nick leans in to kiss Amy.

#### **Amy Elliott: January 8, 2005 Analysis**

Presumably, Amy is writing about when she met Nick for the first time. Amy is recounting the first night of the relationship with Nick, that eventually leads to their marriage. Amy is creating a metaphor between the sugary sweetness of the bakery delivery and the sugary sweetness of her relationship with Nick.



## **Nick Dunne: The Day of Pages 22-32**

#### **Nick Dunne: The Day of Pages 22-32 Summary**

When Nick arrives at The Bar, he finds his sister cleaning glasses and one elderly woman customer. Go asks Nick what's wrong. Nick tells her it's his five year anniversary with Amy. Go asks if Amy is going to do one of her favorite treasure hunts. Nick thinks back to their one year anniversary, which was a disaster because Nick didn't know the answers to the clues Amy left for him to find his present.

Carl Pelley, a retired salesman and Nick's across the street neighbor calls. He tells Nick the front door to his house is wide open and that the cat is outside. Nick recalls how when one of their neighbors found out he and Amy live in their house alone she said how lonely it must be. Nick thinks lonely it is.

When Nick gets home, he finds the door wide open and the cat, Bleecker, sitting on the front steps. Nick finds the glass of the coffee table shattered and the end tables and ottoman turned over inside the house. He goes down to the river to see if Amy's in their rowboat. Amy is gone.

The front door to Nick's house is open and the indoor cat is wandering around outside because something has already happened to Amy. Nick mentions "back when Amy still made him happy" which seems to indicate that he and Amy are having some marital strife. Since this is the case, when Amy goes missing, or is found dead, the police will assume that Nick has something to do with it.

Nick thinks living in the house with Amy is lonely because they no longer have good marriage. It seems as if their relationship is deteriorating. With the turmoil in the living room, the door wide open and Amy missing, it suggests that something bad has happened to Amy. It doesn't suggest that she left on her own accord because she would never allow the indoor, declawed cat she loved to wander outside.



## **Amy Elliott: September 18, 2005**

#### **Amy Elliott: September 18, 2005 Summary**

Amy writes in her diary how Nick turns up again after eight months. He says he wrote her phone number on a sticky note that then went through the wash. Amy says she is perusing the bodega bins deciding what she wants for lunch when she sees Nick sticking to her side. She jokingly says that he certainly takes his time about it. She also says that they are officially together now as a couple.

Amy says the timing is interesting since her parents base a book on Amy. The twentieth book in the series has the book Amy getting married and the book launch party was the night before she runs into Nick again. By this time, Amy is 32, but she feels lonely. All of her friends seem to be married and ponder, as her parents do, as to why a successful, pretty girl like Amy with money is still single.

She wishes for a marriage that isn't like the friends of hers that are married, but have settled.

#### **Amy Elliott: September 18, 2005 Analysis**

It seems as if the relationship between Nick and Amy was not meant to be from the start. This is why there is an eight month lag in time between them meeting and kissing, and them finally getting together again as a couple. Amy is predicting that Nick will become her husband in less than a year from meeting him. Ironically, it seems as if Amy settles for Nick when she marries him as well. This is why their once great marriage is in a downward spiral by the time she goes missing.



## **Nick Dunne: The Day of Pages 39-45**

#### **Nick Dunne: The Day of Pages 39-45 Summary**

Nick is waiting for the police to arrive. He wants to explain to them how Amy would never leave the iron on, the teakettle going on the stove and then there's the sign of the struggle in the living room. Riordan, the male African-American cop, and Velasquez, the female Hispanic, cops show up to the house.

The two police officers call in two detectives, Jim Gilpin and Rhonda Boney. The detectives search upstairs and look around downstairs while they talk to Nick. Nick tells them it's their anniversary. Boney is looking at the wedding picture hanging on the wall while Nick thinks back to finding out how rich Amy was seven months into their relationship. They were married in Cape Cod, which is where the wedding photo was taken. Earlier, Nick spoke about how the treasure hunt ends up being a disaster and making Amy mad because it makes him look as if he doesn't know his wife at all.

Amy also mentions that Nick has been coveting the expensive and Embossed stationary. Earlier, Nick spoke about how it was a gift he didn't like or even want.

It is after midnight when Nick finally calls Amy's parents from the police station, his mother-in-law, Marybeth Elliott, asks to speak to the person in charge after she gets angry for Nick waiting so long to call them. Nick hears his father's voice and then finds him sitting in one of the rooms at the police station. A female officer tells Nick they picked his father up after he wandered away from the home. She says he has a few scraped and bumps, but he's fine. Nick's father keeps saying, bitch, bitch, bitch over and over again.

A police officer drives Nick's dad back to the home, and another gives Nick a ride to Go's house. He tells her what's happening, tells her he's scared and asks her to be nice to him because he has to be back at the station in a few hours. Go says she feels sorry for Amy.

#### **Nick Dunne: The Night of Pages 50-61 Analysis**

Nick is fully admitting to himself and the reader that he has told numerous lies to the police. This makes it seem as if Nick is guilty of something and that is why he is lying. Nick admitting he already decided what he wants to do about their marriage suggests that he intended on getting rid of Amy, so he staged the scene at the house to make it look like there was a struggle after he murdered Amy.

Since Nick's father doesn't like Amy and he has some scrapes and bumps, it could be that he and Amy had an altercation, Nick's father could be the one responsible for Amy's disappearance. Ironically, Go feels sorry for Amy when Nick has made it clear that Go and Amy don't get along with each other and couldn't be more different than they are.



## **Amy Elliott Dunne: April 21, 2009**

Amy writes about a night out for drinks with her fiends Insley and Campbell. While the evening is winding down, the girls wait to see if their husbands show up. Insley and Campbell's husbands do, but Nick doesn't Amy writes about how it's OK with her because she and Nick make fun of girlfriends and wives that treat their significant others like "monkey" or puppets that have to do everything they say. When Nick gets home, Amy finds out he went to play poker instead of meeting her at the restaurant. She says it sounds like more fun than her evening and then they have sex.

#### **Amy Elliott Dunne: April 21, 2009 Analysis**

At the beginning of their marriage, Amy is very accepting of Nick and the way he is. As the years wane on, however, Amy starts to get mad at how inconsiderate Nick is. This is a little confusing to Nick because he is the same way he has always been. While Amy accepted his ways before, now she is getting angry with him. The divergence in their viewpoints explains why the marriage is suffering by the time Amy goes missing.

## **Nick Dunne: The Night of Summary**

Nick continues to drink at his sister's house. He finally catches a short nap right before dawn. When he wakes, he has a little hangover. He drives Go's car to his house to change clothes, and finds three police cars there. Velasquez escorts Nick upstairs to pack some clothes. He asks if he can open the gift wrapped box from Amy to him, but Velasquez says not right now.

When Nick arrives at the police station, Amy's parents are there clinging to each other. He thinks about how the Elliotts are very affectionate with each other, while his own parents divorced when he and Go were 12, and how his father was emotionally abusive to his mother. Nick explains that his father didn't like women in general.

Later that morning, a public relations woman is telling Nick that he needs to make a statement to the public to plea for Amy's safe return. Go also returns to the station after taking care of a few things at The Bar.

During the press conference, Nick speaks but he's struggling because of the hangover. Rand Elliott, Amy's father, takes over for Nick. Nick mentions that he has a "killer smile."

#### **Nick Dunne: The Night of Analysis**

Amy's parents were completely differently role models than Nick's parents were as a basis for a relationship. Since their experiences were so different, Nick and Amy have different viewpoints on how a marriage should be. This no bought continued to the problems they were having in their marriage. In short, their expectations of a relationship are different from each other.

Ironically, when Nick's father gets dementia, they have to move him into a home where women take care of him all day. Nick telling the reader about his "killer smile" during the press conference, while standing next to Amy's weeping parents suggests that Nick is Amy's murderer.



# **Amy Elliott Dunne: July 5, 2010**

## **Amy Elliott Dunne: July 5, 2010 Summary**

It is Nick and Amy's third anniversary. He calls to tell her he's taking the 16 writes that got laid off at his job out for a drink. She's trying to be understanding, but she cries as she drinks wine. When her father calls, she tells him what happened. When Nick gets home, it's 4 am and he's drunk. While she's trying to have a conversation with him, he goes on the defensive.

Nick says Amy doesn't have to work. She says her money is his money. He says not according to the prenup. Nick stomps off to bed. Amy goes through the receipts Nick took out of his pocket and finds a phone number for someone named Hannah. When Amy climbs into bed. Amy is trying to be an understanding wife, but Nick is being very inconsiderate. He turns everything Amy says and does around to be something negative. Some of this is a perception problem. Amy clearly writes her intentions and the way she feels and intends things to be in her diary. The way Nick perceives them seems to be completely different. Of course, without Amy telling him how she feels, or without Nick having access to her diary, he would have no way of knowing how Amy feels except for his own assessment of it.



# Nick Dunne: One Day Gone Pages 82-93

#### **Nick Dunne: One Day Gone Pages 82-93 Summary**

On his way out of the press conference, Gilpin tells Nick they searched the vacant house on their block and another house where squatters were, so they have lab there taking samples. Nick thinks about how the mall used to employ about a fifth of the town, but now many of those workers have been laid off—explaining why there is more of a homeless population than before. One by one, stores in the mall closed, until the entire mall closed. Even Nick's mother lost her job there working at one of the shoe stores.

The detectives take Nick to a room in the police station that has Amy's gift box with the first clue in it. Rand says he told the police about the time Nick saved a mouse form a glue trap at their beach house. When he says that doesn't sound like a guy that would hurt his wife, Nick feels guilty. Nick's disposable phone rings while he's in the hotel room. Nick and Amy's parents talk about a couple of stalkers Amy has had over the years. Amy's mom mentions that they think the person responsible for Amy's disappearance is someone close to home. nick mentions one of her former stalkers lives only 45 minutes away.

#### Nick Dunne: One Day Gone Pages 82-93 Analysis

Nick says that most people don't get to see how things end, but he says that he and Go will get to see how this ends. Nick implies that he and Go will find out that Amy is dead, who is responsible for her death and the punishment they received. Since Nick mentions and Go, it suggests that Nick killed Amy and then at some point Go helps Nick to cover it up.

The clues Amy leaves Nick in the treasure hunt are a glimpse into Amy's emotions over the last year. Since their marriage was in trouble over the past year, Nick suspects her clues will illustrate this to the police. Nick continues to lie to the police because he doesn't want to reveal himself as the killer. Nick has a disposable cell phone because he doesn't want the police to trace the call he makes. It could be a call to an accomplice in Amy's murder.



Nick feels guilty because he has something to do with Amy's disappearance. Nick is trying to put the attention onto one of Amy's stalkers to divert the attention away from his involvement in Amy's murder.

Financial problems are one of the primary reasons that married couples have problems. Amy is starting to paint the picture with her journal entries that money is a constant problem in her marriage with Nick. these problems compound when Amy's parents also find themselves in financial straits. The inference is that Nick might have disposed of Amy to collect on life insurance.



## **Nick Dunne: Two Days Gone**

#### **Nick Dunne: Two Days Gone Summary**

Nick spends the night on his in-laws pullout couch in the hotel. While he's normally a heavy sleeper, he finds himself suffering from insomnia. A ballroom of the hotel is the headquarters for Amy's search party. Lots of people Nick knows show up. One of them is his old high school friend, Stucks. Stucks tells Nick that the "Blue Book Men," which are the factory workers that used to produce Blue Books for schools are camping out at the empty mall now. He says a girl was raped there last month. Stucks says he told the cops they should be searching the mall.

The cops send Nick out with the search party for one of the parks in the area. the cop has him as a greeter because Nick realizes they don't want him near any crime scenes. One of the women that Boney says is a "groupie" approaches Nick, essentially tying to hit on him through her sympathy. She ends up taking a picture of them together with her cell phone—the picture looking like they are spending a day at the baseball game.

#### **Nick Dunne: Two Days Gone Analysis**

Nick's insomnia stems from his guilt. It's keeping him awake. Nick is looking for any and all events and locations that point the blame away from him and toward another person. Nick says he would even hate the guy in the cell phone picture because Nick feels guilty. His guilt is making him hate himself as much as everyone else will hate him when they find out he murdered his wife.



# **Amy Elliott Dunne: September 15, 2010**

## **Amy Elliott Dunne: September 15, 2010 Summary**

Amy is cooking breakfast when the phone rings. She hears the voice that Nick uses when he talks to Go as he goes into the other room for privacy. When he returns, he tells Amy that his mom has stage 4 cancer. When he mentions his dad's Alzheimer's, Amy is shocked because Nick never told her about his dad being sick.

Amy suggest looking into a nurse, but Nick says his mom's insurance won't cover it. She knows it's a dig because they could have paid for her care if she hadn't given all their money to her parents. Nick tells her they are going to do the right thing, which is move to Missouri and take care of his mom.

Amy and Nick are packing a U-Haul for their move. When they have enough room in the truck for the bed they've promised to a friend, Nick asks Amy if she wants to take it. He mentions not wanting to hear about it anymore if she decides not to take it. She says no. as they drive away, Amy feels as if she is a piece of trash to be tossed in the trash or the river. She says she feels as if she could disappear.

Nick isn't confiding in Amy as a husband typically confides in a wife. It seems as if Nick is moving away from their marriage and Amy senses this. He doesn't even consult Amy about the move. Instead, he tells her what they are going to do—as if Amy is a possession rather than an equal to Nick. Amy's feeling that she is a possession that could easily be tossed out or disappear is foreshadowing of Amy's demise.



## **Nick Dunne: Three Days Gone**

#### **Nick Dunne: Three Days Gone Summary**

The search parties are back at headquarters. Everyone's sentiment is that Amy will only be found if the killer wants her to be found. Nick's disposable cell phone rings. It's the someone he called returning his call, but he can't answer it now. Marybeth catches Nick's attention.

She tells him Amy's stalker from high school, Hilary Handy, lives five hours away in Memphis. She pleads with Nick to drive there and check it out since the police won't. He agrees and says he'll also stop off to visit the other stalker, Desi, in St. Louis. Maureen Dunne is Nick and Go's mother. Her friends call her Mo. She divorces their father when Nick and Go are kids. When Mo has cancer, Go and Nick return home to help care for their mother. Amy, too, takes Mo to cancer treatments and doctor appointments. Mo dies shortly after Amy and Nick move back to Carthage.

#### **Bill Dunne**

Bill Dunne is Nick and Go's father. When they were younger, he was abusive to their mother. Neither Nick nor Go have a close relationship with Bill Dunne. Bill Dunne is living in an assisted living facility because he has Alzheimer's. Throughout the novel, Bill Dunne escapes from the home. The home threatens to evict Bill Dunne from the home if he continues to escape.

#### **Rand Elliott**

Rand Elliott is Amy's father. He is also one of the authors of the Amazing Amy series. Rand is also a psychologist. Rand is an emotional man, so his daughter's disappearance deeply affects him. Throughout the novel, he stands up for Nick's innocence, although this wanes a little when he finds out that Amy is pregnant.

# **Marybeth Elliott**

Marybeth Elliott is Amy's mother. She is also one of the authors of the Amazing Amy book series. Marybeth is also a psychologist. Throughout the novel, she stands up for Nick's innocence. When Marybeth finds out that Amy is pregnant, she cuts ties with Nick.



# **Rhonda Boney**

Rhonda Boney is one of the detectives investigating Amy's disappearance. She is one of the only people that believe Nick is innocent. Boney even continues to help Nick try to prove Amy is behind her own disappearance. #### **Andie**

Andie is a college journalism student. She meets Nick while taking his class. Andie and Nick have a yearlong affair. Andie is 25-years-old and very pretty. When the media finds out about their affair, Andie becomes a media darling. When Nick breaks off the affair with Andie, she moves on and starts dating a guy that is closer to her own age.

#### Greta

Greta rents the cabin next door to Amy when Amy is hiding out in the Ozarks. Greta appears to be hiding from a man that was abusive to her. Greta sees all of the cash Amy carries, so Greta ends up robbing Amy, along with another cabin resident, Jeff.



# Jeff

Jeff rents one of the other cabins where Amy rents a cabin when hiding out in the Ozarks. Jeff steals fish from a lake behind a seafood restaurant nearby. He hires Amy to help him one night and pays her fifty dollars for two hours of work. Greta tells Jeff about all of the cash Amy carries, so he and Greta rob Amy of all her money.



# **Objects/Places**

# **New York City**

New York City is where Amy and Nick are living when they meet. They also live there for a few years after they marry. They leave New York City to move to Nick's hometown when his mother falls ill with cancer.

# Carthage, Missouri

Carthage, Missouri is Nick's hometown. It is where Nick and Amy move to help Nick's mother when she's sick. Go is also living in Carthage at the time. Nick and Go open a bar together in Carthage. Amy goes missing from Carthage, Missouri, as well.

#### Hannibal

Hannibal is a town close to Carthage. Hannibal is the hometown of Mark Twain, so there are numerous tourist attractions honoring Mark Twain and his character Huck Finn. Hannibal is where Nick had a summer job growing up. Hannibal is one of the places Amy hides a clue in the treasure hunt for their fifth wedding anniversary.

#### The Ozarks

The Ozarks is a mountainous area where Amy goes after she disappears. Amy rents a cabin in the Ozarks. She spends a couple weeks there following the investigation on the news. This is also where Amy meets Jeff and Greta, who rob her of all of her cash.

# Diary

Amy starts writing a diary when they move to Carthage. She backdates the entries in the diary to make it look as if she was writing the entries while it was happening. She purposely twists the events around in the entries to make it seem as if Nick is trying to kill her. Amy plants this diary in Bill Dunne's vacant home and then calls in an anonymous tip so the detectives find it.

# **Disposable Cell Phone**

Nick has a disposable cell phone, in addition to his regular cell phone. He uses the disposable cell phone to communicate with Andie. Nick continues to use the disposable cell phone to communicate with Amy after Amy disappears. Amy also buys a disposable



cell phone in preparation for her disappearance. She uses her own disposable cell phone to call in the anonymous tip so the police find her diary.

An abandoned Fort on the outskirts of Carthage is one of the rendezvous spots for Andie and Nick during their affair. Nick and Andie have sex in the abandoned Fort prior to Amy going missing. Andie has Nick meet her at the Fort after Amy goes missing.

#### Woodshed

An old woodshed sits behind Go's house. Nick finds all of the items that were purchased on the credit cards he didn't know about inside of the woodshed. The police also find the items inside of the woodshed. When Amy put the items in the woodshed, she also puts Nick's anniversary present, which are the wooden Punch and Judy puppets.

## **Amazing Amy Books**

"Amazing Amy" books are a children's book series. The authors are Rand and Marybeth Elliott. The Elliotts base the topics of the books on events that happen in Amy's life. The book series is also responsible for the sum of money the Elliotts provide to Amy.

#### **Lake House**

Desi owns a lake house. This is where he takes Amy to help her hide after she leaves the Ozarks. Amy kills Desi is the lake house.



# **Themes**

#### **Good versus Evil**

The primary plot throughout the entire novel is that of good versus evil. In the first half of the novel, Nick represents evil and Amy represents good. As Amy recounts events in her diary, she is painting Nick as a selfish man that is trying to push her away.

Amy even implies that she thinks Nick might try to kill her and that she is very afraid of him. In the same Diary entries, Amy creates a persona where she is a very loving wife trying to turn her failing marriage around. In the second half of the novel, Amy reveals her true personality.

She is actually conniving and manipulative. She admits that she is the one responsible for staging her own disappearance and death. She also admits to setting Nick up to take the fall for her disappearance and murder. In reality, Amy represents evil and Nick turns out to represent good.

#### **Mental States**

Another primary theme of "Gone Girl" is the mind or mental state of human beings. Primarily, the focus falls on the sanity, or insanity, of Desi, Hilary and Amy. Amy tries to make it seem that Desi is a stalker and that he is mentally unstable because he tries to commit suicide when Amy breaks up with him.

Amy also tries to make Hilary seem insane. Amy talks Hilary into buying clothes similar to Amy's clothes and play a joke on Amy's mother saying Hilary is her daughter now. Amy is trying to make it look as if Hilary is trying to be Amy as payback for getting better grades, getting a date with a boy and other things that Amy didn't like.

Ironically, even though Amy is the daughter of two psychologists, it seems as if Amy is sociopath. She methodically plans to frame her own husband for her disappearance and death. She manipulates anyone she can to help her carry out her plan. She even ends up killing Desi, who was helping her to hide, to make it seem as if he kidnapped and raped Amy.

# Relationships

Relationships are a third major theme that runs throughout the novel. Specifically, the novel speaks of the relationships between family members. In this particular case, it is the relationships between the Dunne and Elliott families.

The relationships in the Dunne family seem to be the polar opposite of the relationships in the Elliott family. Nick's parents are not affectionate toward one another. They seem



to be going through the motions of a marriage, rather than enjoying the time they spend married to each other. Ultimately, Mo and Bill Dunne divorce.

Marybeth and Rand Elliott are very affectionate toward one another. They always seem to be kissing, hugging, holding holds or walking with their arms around each other. They are still married and they have and still do dote on Amy.

Then, there is Nick and Amy's marriage. Amy and Nick seem to have completely different perspectives on their marriage. Both seem to admit being very in love with each other when they first started dating and during the first few years of their marriage. While they can't seem to get enough of each other to start, by the time Amy goes missing, they are not even having sex anymore and Nick is planning to ask for a divorce.

Family is the central theme throughout the entire novel. This is because the storyline is about the lives of these two families—the Elliotts and the Dunnes. While every family has their trials and tribulations, these families have its own family dynamics that are the same and that are different from those of other families. In the end though, each family ends up pulling together to get through the situation together.



# **Style**

#### **Point of View**

"Gone Girl" is written in the first person point of view, from the perspective of each of the two main characters, Nick and Amy. Each section is from one of their perspectives. Then, the next section alternates to the other character's point of view. The novel swings back and forth between the present and the past. The present represents the time after Amy's disappearance. The past represents the time leading up to her disappearance.

The point of view of this novel is intimate, allowing a reader to connect closely with each of the main characters. The book written in this manner allows the reader to get inside the heads, thoughts and inner struggles that each of the characters are experiencing as it pertains to the plot. The point of view also allows the author to inject her own opinions into the narration and to expand on the events taking place around the other characters and the occurrences taking place.

## **Setting**

The novel is set primarily in Carthage, Missouri, which is Nick's hometown, and where he and Amy are living when Amy disappears. The novel takes place during the 21st century. The novel covers the five-year period when Nick and Amy are married. The main characters are involved in the aftermath of Amy's disappearance and the investigation that Nick is responsible.

The setting of this novel works well with the plot. At first, the reader is not aware that Amy is framing Nick for her disappearance and murder. However, as events unfold, the disappearance is a constant part of the plot, the lives of the characters and even the outcome of the novel.

### Language and Meaning

The language of this novel is relatively simple and easy to read. The language is from the 21st century, which is when the novel is set. The language is descriptive enough that it helps to explain the situations and is detailed enough for the reader to truly understand.

#### **Structure**

The novel is divided into sections. Each section is from the perspective of Nick or of Amy. The perspectives alternate throughout the book. The length of each sections ranges from one page to 20 pages long. The chapters tell the story primarily in



exposition and with some dialogue. The narrator injects her own voice and thoughts throughout the book, providing her opinions and feelings of the events unfolding in the novel.

The novel contains one main plot and several subplots. The main plot is the struggle of human beings in choosing between good and evil. One subplot is the mental states of the characters. Another subplot is relationships.
