Plot Summary

"The Weight of Silence" by Heather Gudenkauf tells a story about a parent's nightmare. When Calli, a seven-year-old selective mute and her seven-year-old best friend go missing, an investigation ensues.

As the story opens, Calli has to go to the bathroom, but she is scared to go downstairs because her father might be there and see her. He is getting up early to go on a fishing trip with a friend. Finally, she can't wait any longer and she goes downstairs. He sees her and she notices that he has been drinking. In his drunken state, he accuses her of being the child of his wife's childhood sweetheart. Instead of going fishing with his friend, he literally drags Calli off into the woods to see the house of the man that he thinks is the girl's real father.

On that same day, very early in the morning, Martin and Fielda discover that their daughter is missing. They call the police and begin an investigation. A year before the girls' disappearance, another girl had been taken from her house. The police had found her, days later, dead. The local sheriff calls for help and the family members in both households are interrogated. They look for clues and talk with the press.

Griff, Calli's father, becomes even more physically abusive and she runs away. She goes into a part of the woods that she is not familiar with in order to escape from him. Meanwhile, her brother comes looking for her.

Near the end of the day, she stumbles upon her friend, Petra, who is badly beaten and nearly unconscious. Griff also stumbles upon the scene and tries to persuade Calli to go home with him. While he is doing this, Ben, Calli's brother, comes across them and thinks that his father is responsible for beating up Petra. He sends Calli off to get help. She comes out of the woods and speaks one word. It's the first time that she has spoken in four years. She says Ben's name, making him a suspect.

Calli goes to the hospital with her mother and Martin and the deputy sheriff climb up the bluff to rescue Petra. A helicopter comes and takes the girl away to a city hospital, and they go down the mountain with Ben. Griff has disappeared. Martin decides to go back to kill Griff. Ben goes to the hospital to join his mother and sister.

Antonia, Calli's mother, goes to the house to get her daughter some things and she goes to the edge of the woods. Her husband comes out and drags her into the woods. They fight, and the police show up. Griff has a gun, and the police shoot and kill him in self defense.

Calli tells what she saw, and the families realize it wasn't Ben or Griff. The man who abused Petra was a student that Martin's family had befriended. Six years later, things are almost back to normal. Calli is a typical teen going to school and playing in sports. Petra didn't fare so well, but she is alive. Her family moves away and the girls still keep in touch.

Antonia and Louis see someone running out of the woods and tries to embrace the silent person. She is so happy to see her, but the girl goes right past her to the deputy sheriff. The girl speaks for the first time in three years.

Calli wakes up very early in the morning. She hears her father downstairs as he gets ready to go different. She has to go to the bathroom badly, but there is only one bathroom in the house, and if she uses it, her father will see her. Calli looks around her room to distract herself and sees her school materials. She is about to go into second grade. She loves school, but she doesn't like how the teachers are always trying to get her to talk. Her kindergarten teacher thought she was just shy until she began having accidents.

The nurse at school, Mrs. White, was very kind when Calli had her accidents. She would document the accidents. She notifies Calli's mother after nine accidents, telling Calli that she is going to do so, but reassuring Calli that the girl is not in trouble. The Solution-Focus Team of educators test Calli, and can't find anything wrong with her aside from the muteness. They decide to teach her American Sign Language so she can tell others when she has to go to the bathroom.

Calli really needs to go to the bathroom now. She thinks about going in her trash bin, but she knows she will worry her mother if she does this. She considers climbing out the window to go outside, but she knows this is dangerous. Calli decides to try sneaking to the bathroom without her father seeing her. She hopes her father has already left. Life is more peaceful without him around.

Some days her father is happy and fine. Other days he had beer cans all around him, and it was best to avoid him on those days. Calli would run to Willow Creek Woods to play on those days. She wouldn't come home until he was gone.

Her father is there and he hears her this time. He starts off nicely, greeting her in a friendly manner, then he ridicules her for her muteness, calling her "dumb like a retard." His friend Roger comes by to pick him up, but he tells Roger to go on without him. He'll catch up later. Her father tells Roger that Calli needs some "daddy time." He grabs Calli and starts dragging her into the woods. She has an accident, and urine floods down her leg.

Petra can't sleep because of the heat. Her necklace is sticking to her. She hears a noise outside and checks it out because she is scared. Now she isn't scared, and she decides



to go out to it even though she knows she shouldn't. She rationalizes that it's all right since she is going to be with an adult outside. She plans to come right back in.

Calli's father dragged her off, but she knew where she was in the woods. She also knew there wasn't much chance of anyone else seeing them in the woods. She knew they weren't near Deputy Sheriff Louis' home. She wasn't sure if this was a good thing or a bad thing. Her feet were scratched and hurting, but she knew her father would cause problems at the deputy's home. Calli was trying to figure out how to get away from her father. As they go through Willow Wallow, the author notes that Calli's mother, Antonia, played with her children in the area. Calli picnicked with her mother and brother, Ben. They made up stories, climbed trees, and felt happy. Griff, her father, was the opposite. He was the kind of man who dragged his daughter off while he was drunk.

Martin and Fielda cuddle close together in spite of the heat. They've only been separated twice in 14 years of marriage. Martin remembers meeting her. He was a professor, and she was a waitress at Mourning Glory. After a year, she three a muffin at him to get his attention. Martin gets out of bed and goes to check on Petra. She isn't there. She isn't downstairs, either. He wakes up Fielda to tell her and the two hunt for the girl then call the police. Deputy Sheriff Louis comes to their house to discuss the situation.

A noise wakes up Antonia. She remembers that Griff is gone on his fishing trip. Someone bangs on the door, and she is annoyed. As she walks down the hallway she thinks about her children. Louis and Martin are at the door. They ask if Petra is there then ask to talk with Calli. Antonia realizes Calli is missing, also. After searching her house, the adults wonder if the girls have gone off together. It's six in the morning. Martin points out that his daughter has been missing since at least 4:30 AM. Louis asks if Griff might have taken them fishing, and Antonia laughs at that idea. He doesn't like children enough to do that. Ben suggests that the girls went into the woods.

Ben wakes up form a dream in which he his helping Calli climb a tree then can't join her because he can't climb it himself. He feels guilty that his sister is missing because he feels responsible for her. Ben remembers when he let her down in the past. He also remembers that he left Tootsie Rolls under her pillow as a way to apologize.

Griff falls asleep still holding Calli's arm. She thinks about Ben and things he has taught her about the woods. Griff wakes up and asks her which way to go. She leads him to the sheriff's house. They see the sheriff's wife in the yard. She's talking on the phone angrily. Overhearing her conversation, they realize that everyone thinks Calli and another girl are missing. Calli wonders who the other girl is.

Martin has searched all of his daughter's favorite places. He remembers the night Petra was born. He reflects on his own childhood. He was poor until his father asked for his help on the farm. Using his gift for words and numbers he got the family's accounts in order. They weren't rich, but they were better off than they were. Martin remembers holding Petra for the first time. He feels as if he has let his family down now that his daughter is lost.



Louis calls in to say that he thinks the situation is more than just two girls running off. The sheriff wonders if it's similar to the McIntire case, which was an abduction and murder of a 10-year-old named Jenna McIntire.

Petra is trying to keep up, and they won't stop. Finally, she hears a voice calling to her.

As the day goes on, Griff is getting more quiet, and Calli is getting nervous. She remembers good times with her brother as her father starts rambling on about his wife's supposed relationship with the sheriff. He shoves Calli away, and she tries to talk with him. She remembers good times with him, too. Griff starts kicking her. She runs away.

The family is barred from Calli's room so the police can sort through things. Martin is extremely worried about Petra, but Antonia isn't as worried about Calli because she knows her daughter is forever running off. Antonia kept trying to call Griff on his cell phone, but he wasn't picking up. She doesn't want to call her brothers because she feels that it's to frightening to put the fact that Calli's lost into words is too frightening. She has faith that Ben will find the girls.

Martin and Louis hope to find the girls at Antonia's, but they aren't there. He notes how beautiful Toni looks. Antonia says Ben is out looking for the girls. They discuss the situation while drinking iced tea. Antonia explains that the woods is like a second home to Calli. Martin says Petra isn't allowed into the woods without an adult. Louis suggests that they let the public know that the girls are missing. They discuss the unique friendship between Petra and the mute girl. Petra always seems to know what Calli needs. They are kindred spirits. Toni looks for Calli's shoes and realizes the girl is barefoot. She looks scared, and Louis reaches out to comfort her.

Ben searches all the regular areas in the woods. He wonders if his father did take the girls fishing with him, and he recollects a time when his dad took him fishing. They had a good time. He doesn't really think his father took them with him, though. He remembers what a good sport his little sister is. He isn't sure why she stopped talking when she was four and he was nine. It was very sudden.

Griff chases Calli as she runs away. His rage reminds her of that day in December when she was four. Her mother was seven months pregnant with her sister, and her father came home drunk. While they were arguing, he help Calli tightly, scaring her. Griff accidentally knocked Antonia down the stairs then got angry because Calli wouldn't stop crying. He whispered something to her then left. That evening her mother gave birth to a dead girl. Now, from her hiding place, Calli sees a man, but she remains hidden because she doesn't want the man to hand her over to her dad.

Section 1-850 Analysis

This section is written as if Antonia is talking to the girl. As the novel opens, the reader has no idea what is going on, but there are clues. A woman sees a dirty girl coming out of the woods and is filled with relief. This implies the girl was missing. The girl is silent, but the woman is used to that. She shows love for the girl by thinking that she would



never force the girl to say a sound, but she is so thrilled to have the girl back in her arms. The girls doesn't go to her arms, however. The woman isn't upset. She is proud that the girl is being smart. Something has happened that is traumatic enough to get the girl talking again. She says one work, and the word is powerful enough to distress Petra's father. The scene is emotionally mixed. The woman feels horrible for Petra's father, but she is relieved to see the girl, and she is very joyful and thankful that the girl talks after three years of silence.

This section is written in third person omniscient in past tense. Although it's third person, it delves into Calli's though processes. The reader gets to meet the mute girl in this section. It's August in Iowa. Calli lives in a decent house with her parents. She has her own bedroom and a chenille bedspread. She has materials ready for school. This shows that someone in the girl's life cares. She loves school even though the adults in school don't understand her muteness. She has accidents, but it doesn't appear to bother her. The teachers and nurse are understanding and supporting.

It's very obvious in this chapter that Calli wants to avoid her father if at all possible. However, when it comes to a choice of distressing her mother or facing her father, she chooses facing him. This shows that she really cares about her mother and her mother's feelings.

Calli's father has a drinking problem. He is moody as a result of this. When he's not drinking, he's a wonderful father, but when he is drinking Calli tries to stay away from him. The problem each day is that she never knows when she goes downstairs whether or not he is drinking alcohol. At the end of the chapter, the reader realizes that the father doesn't believe her really is Calli's father, and he's bitter about the fact.

The section about Petra is written in the first-person present tense. The reader finds out that it's very hot, and the girl hears something outside. She has a strong enough sense of self to face her fear as she goes over to see what is making the noise. Something she sees calms her, showing familiarity. She is drawn enough to whatever she sees that she is willing to break rules she knows she ought to follow to go outside to meet it.

This is written in the third-person past tense. Calli knows the woods much better than her father does. It's unclear whether he's lost because he's drunk or because he just doesn't know the woods like she does. They pass through areas that hold good memories for Calli. Her mother is shown in stark contrast to her father. Her father grips her tight and doesn't care about the fact that she is barefoot, and her feet are getting scratched. Her mother plays with her, encourages imagination, and provides food. In this chapter the reader learns that Calli is seven-years-old.

The next section is in the first-person present tense. Martin and Fielda have been married for 14 years, and he still loves her passionately. This section depicts a very close family and offers insight into Martin's character. He loves his life and his family, and when his daughter is missing, Martin doesn't worry about embarrassment or looking like an unfit parent. He calls in for help as soon as he can.



The following section is written in first-person present tense. Antonia wakes up to a sound she thinks is thunder. Her first response is to wake her children so they can enjoy it together. This shows their closeness and love for nature and for each other. She realizes her husband is gone. This shows a distance in their relationship since she didn't get up with him to see him off on his trip. Antonia reflects on the roles of the men in her life. She is in awe of her daughter and feels as if she doesn't really know how to take care of the girl due to her male-dominated background.

Louis and Martin are at the door, and Louis betrays a special closeness to her when he mentions her name. He is the only one who calls her Toni. As Antonia invites them in, she is embarrassed by all the beer cans littering the place. Even when she is under stress, Antonia thinks about her children. She notices Ben's hair needs cutting, and she is concerned about hiding spots for the children's games. Both Ben and Antonia show that they aren't too nervous about the girls. In fact, Ben isn't even going to start looking for them until he finishes his paper route. Nobody objects.

Written in the first-person past tense, Ben talks to Calli in his section. He has a symbolic dream where he is taking care of her and is concerned for her, yet he can't keep up with her. He was only a child himself when he was put in charge of her, but he still takes the responsibility seriously. He remembers a time when he shirked his duties and left her to her own resources. He tried to make her feel better by giving her candy under her pillow. They didn't discuss the situation.

In this section, the reader gets the first inkling that Calli is ashamed of the fact that she has accidents. As she stays trapped by her father, her mid wanders, and the reader sees how much she admires her brother. He has taught her a lot, and they have good times together. When her brother gets hurt, her mother takes care of him. Now Calli is hurt and hungry, but all her father cares about is finding the Sheriff's house. He asks for her help, and she has the option of lying. As much as she doesn't want him to find the place, it's better than staying in the woods with him. They arrive in time to hear the sheriff's wife accusing her husband of running off to help Antonia. Calli is relieved to know that her mother is aware that she is missing, and she is concerned about the other girl. She wants to get home where she can be cared for.

Martin knows his daughter, and he knows where she plays. He came from a hard-working yet poverty-stricken background. Always academically inclined, Martin felt as if he let his father down until he figured out how to use his talents to help the family. He is a good provider now, yet when his daughter is missing, he takes the loss personally, feeling as if he has let his family down.

This section is written in the first-person present. This story takes place in a small town, and it's obvious. Louis has a bad vibe about the situation, and his co-worker believes him. They don't stand on ceremony or follow a rulebook. They immediately begin calling others for help based on the vibe. Although it's a small town, crime isn't a stranger. A young girl was abducted and killed a year before.



This is a one-page chapter that shows something is wrong with Petra's plan. She knows what she saw outside her window and was comfortable enough to go out for a greeting. Instead of staying there, the characters ran away from her, luring her away.

Calli went into the woods with her father because he had never hurt her. This changes in this section as Griff lashes out at her physically. She runs away from him.

It seems as if the reality of the situation isn't reaching through to Antonia. She can't believe her daughter's room is being taped off. She is basing the scenario on past situations. Calli was always wandering. As she filters through a mental list of people she should contact, the reader realizes that Antonia is very much alone. She doesn't want to voice that there is a problem because then she would have to accept that this was true. The reader can't help but wonder if this is symbolic of Calli's muteness.

The upbringing of the girls is highlighted in this section. They are from different backgrounds - Calli is encouraged to play in the woods and Petra is kept away from it unless she is with an adult. There is a subtle friction between Martin and Antonia, both both are grateful for the friendship between the girls, who seem to balance each other. Both parents are on edge and react when it seems as if others are judging their parenting abilities.

Ben is determined to find his sister. Even though she sometimes annoyed him, she is very special to him. He feels very protective of her, and a little bit lost on how to deal with her. He doesn't know why she stopped talking, but it took a bit of light out of his world.

All Calli wants to do is get home, and she is terrified her father is going to catch her. She hides and reflects on her situation. Griff's anger flashes Calli back to the night she stopped talking when she was four. The night had begun well with Calli and her mother discussing baby names. Griff came home drunk and began accusing Antonia. In his drunken rage, he didn't care that he was scaring young Calli, just as he didn't care about her in the woods. His jealously took over, causing harm to those around him. He whispers to Calli, and the words he said haunt her to the present day in the woods. She is so terrified of him that when she sees a man who might helpe her, she continues hiding because he might return her to her father.

Sections 851-1604 Summary

Fielda waits at home while Martin is working on the business end of finding their daughter. Martin has the difficult task of putting up fliers. As he puts them up, he understands that people might think of him as a suspect. Still, his memories of his daughter make every inconvenience worthwhile. He remembers how everyone loves her, and he thinks of how she reaches out to help others. She is creative in her solutions.

Although Antonia doesn't have friends, she still reaches out to call everyone she can think of regarding the missing girls. She and Martin have different parenting styles, as the reader sees earlier in the book. However, they both have the same reactions to this situation. They loved their children with a passion and are greatly distressed by the disappearances. They feel that others are judging them, but ignore the responses and keep contacting others in hopes of finding the girls.

She reflects on the fact that she wasn't proactive enough when Calli first stopped talking. In a way, her daughter began to go missing then. She expresses doubt over the relationship between her husband and Calli for the first time when she realizes that she never asked Griff what he told the girl. She never asked Calli, either. She is very appreciative of Ben. He supports her more than her husband.

Calli is protecting herself from life's harshness when some of life's beauty lures her out of her hiding. She and the fawn are mirrors of each other - dancing around each other, wondering who they can trust.

This section demonstrates the personal and professional passion Louis has for the case. He is quick to call in extra help. A city boy relocated to the country, he knows this is more than he can handle alone. The image of little girl reminds him of the mother he fell in love with when they were both young children, the same age as this little girl.

Ben sees himself as the family protector when his father is away. In retrospect, he wonders what his father was like when he was gone. The man would beat on him to try to make Calli talk. Ben knows Calli felt horrible about this. She let him down, and now he is letting her down by not finding her and keeping her safe.

All the talking is beginning to irritate Fielda and Martin. They want action. Fielda is visibly falling apart, and Martin tries to protect her even as he wants to rush out and physically start searching. The police have been through this before, and even though it's excruciating, they know they must conduct detailed interviews so they don't spend useless time hunting in the wrong direction. When Martin blows up, they understand. Fielda and Martin grieve together as a single unit.



Although he was originally from the city and he went to college in the city, Louis shows that he is a country man at heart. His job isn't easy, and he knows the horrible things that could happen to Calli and Petra. He separates himself from his personal thoughts and thinks objectively about the situation, doing what must be done. He has a personal dislike for Griff and informs Fitzgerald about the man, but he doesn't go into great detail. He just warns him about Griff's violence and emphasizes that the warning is based on rumor, but might prove true. By the end of the chapter, Martin and his wife had gotten their emotions back under control and were ready to work with Louis and Fitzgerald again.

All her time in the woods helps Calli as she fights off fatigue, hunger, and thirst. She knows which berries are all right to eat and what to avoid. She also knows to find shade and shelter when she sleeps. Calli is in unknown territory, yet her desire to avoid her father prevents her from going back into familiar territory. Hunger and thirst are better than facing him now that he has crossed the line and hit her.

Ben wants to get out into the woods to search for his sister. He knows she loves it there - a thought that is emphasized by her box of treasures. The cotton in the box shows a whimsical side of Calli and her mother. It's reminiscent of their imaginative play in the woods mentioned in previous chapters. Ben knows his sister well enough to realize that they share the same wishes - at least when it comes to having their father disappear from their lives.

Antonia cares for her son, making sure he eats. She reflects on her life choices, realizing that Louis was all she ever needed. When she felt abandoned by him, she cut him off, ending out on the path that led her to a very unhappy marriage. She knows that Griff has a good side to him, and part of her loves him. However, his drinking is more important to him, and it turns him into an unlovable man. Antonia can't help thinking she destroys everything she is a part of even though her children adore her.

Louis and Fitzgerald are at Antonia's house. He sees the situation personally while Fitzgerald sees it professionally. He's a cop, but he's not very physical. He plays by the rulebook, and Griff knows this. It's the reason he isn't out searching for Calli right now. He's going by the book, interviewing and setting up procedures.

Even though Ben is a young boy craving his father's attention, he can't seem to get his father's approval. He remembers his failure on the soccer field. Ben wishes his father would yell at him, but he's just quiet. Silence plays a big role in this novel. Ben's father's silence is hard to deal with and so is Calli's silence.

Antonia is a country girl, and the new cop doesn't look very country. She is relaxed and seems flippant with her answers. She seems to be blocking the reality of her daughter's absence. Instead of seeing the police as a help, she feels judged until Louis pulls her aside to stress the importance of taking the questions seriously. Due to her connection with him, she is able to let down and show some of her insecurities about the situation.



Petra is Calli's strength in school, but now we see that Calli is Petra's strength as well. The reader begins to understand the girl's character more now. She is kind-hearted and willing to risk unpopularity to help others. She is also resourceful socially, but she isn't very resourceful physically. She can help other accept Calli, but she can't assuage her own thirst.

Ben and Louis both know how close the relationship between Louis and Antonia. This makes Ben skittish, and it makes Louis jealous. The reader isn't sure if it's because Griff has a son that looks like him and Louis doesn't or if it's because he wishes Ben were his son. Up to this point in the story, Ben comes across as kind, caring, nurturing, and protective. In this section the reader sees a different side of him. He is reminded of something unpleasant in his past, and he lashes out.

Antonia, who thinks she ruins everything, is just to run in and protect her son. She is getting tired of the police "help" and is ready to take matters into her own hands. She is left alone to her thoughts, memories, and un-fulfilled wishes. Antonia turns to nature to soothe herself and sees evidence that proves that the police were right to be concerned. Instead of trying to deal with this new evidence on her own, she hurries to inform the police, even though she doesn't appreciate the way they are dealing with the situation.

Fielda and Martin's marriage and love for each other seems so perfect, but in the section the reader discovers that it wasn't always ideal. The reader also realizes that Petra was the child that Fielda always wanted although it seemed like parenthood would never happen for them. This makes this situation all the more tragic. They waited so long for her, and now she's gone. Martin let Fielda down in the past regarding children, and now he's letting her down again in his mind.

Martin goes home and tells his wife they still haven't found their daughter. They decide to put fliers up around town. Martin goes to his office and thinks about everything that occurred that day. He remembers how Petra loved playing under his desk while he worked. His co-workers and students all love seeing the girl. Martin remembers one student, Lucky Thompson, who was particularly distressed, and Petra came up with an idea to help him.

Antonia calls everyone she can think of, trying to get information about the girls. She feels as if others are judging her when they hear the news. She feels like she should have put up signs when her daughter lost her voice, too. Antonia reflects on the way they took Calli to a doctor and a counselor. She wonders what Griff said to Calli the day her daughter died.

It's very hot out, and Ben comes out of the woods. He didn't find Calli, and he apologizes. After a cool drink, he plans to go out searching again. The police call. They can't get a hold of Griff or Roger. As Louis talks on the phone, Antonia suddenly realizes



that her husband might be a suspect. Louis reassures her that he will be there during all questioning. He tells her he reported the girls' missing status to the National Crime Information Center. He has also notified the Bon the Lookout bulletin for the county. Ben and Antonia get ready for the police to show up and question them.

Calli is still in hiding, scared to come out when she hears a noise. It's a fawn. Both scared, the girl and the fawn take tentative steps toward each other.

Louis continues his search strategy, appointing David Glass, a reservist, to park between the homes to gather information and be a point person. He remembers when he and Toni met when they were seven. He had moved in from Chicago and felt out of place. On his first day of school he saw a daredevil girl on a sled and fell in love. Now, in the present day, a visitor interrupts his reminiscing. It's Agent Fitzgerald from the state police.

Watching everyone set up for the search, Ben is amazed at the fuss Calli is creating, even without saying a word. He remembers how Calli seemed disappointed whenever he slept at a friend's house. He only did that when his father was home because he never wanted to leave his mom and Calli home alone without protection. He thinks about how his father tried to get Calli to talk. When she didn't Dad became angry. He would hit Ben so Calli would be forced to talk, but she couldn't make the words come out. Ben knew she felt horrible about that because he found Tootsie Rolls under his pillow for the next two weeks.

He asks his wife if she is up to driving to lowa city on her own because he wants to help with the investigation. Mary Ellen McIntire offers to go with her. After they leave, he gets a gun.

Sections 2478 - 3224 Analysis

A new suspect comes to the forefront in this section. Some people are already blaming Griff while others are suspicious of Ben. Now the counselor at the school, Charles Wilson, has some incriminating evidence against him. Louis intuitively feels that something is wrong with the idea of treating Wilson as a suspect, but he doesn't let his emotions take over procedure. This is true to his character. When he gets the phone call, he is upset that it wasn't Toni on the other end. He is as tied to her mentally as she is to him.

Antonia is reassured by the fact that Louis is on his way. She is ready to go off on her own to search for the missing girls. Instead of waiting around for the police to tell them what to do, Martin and Antonio are taking matters into their own hands. Martin is a bit



out of his league because he doesn't know the woods very well. Louis and Antonia grrew up in the woods and know exactly where to look.

Ben is used to taking care of his little sister, especially where his father is concerned. Now he transfers his care and concern to Petra. He is very grateful to the girl for her role in his sister's life. Now, when his father disappears, it's a hard hit for him. Even though his body is large enough to take on his own father, this section shows that Ben is still very much a little boy in need of his mother's comfort.

At the beginning of the book, the reader knows that Louis' wife is upset that he is running off to help Antonia. He clearly defines his priorities in this section when his wife calls him and complains that he isn't home enough for their son and warns him that he is a threat to their marriage. He is distracted by the events happening in Antonia's world, and he hangs up on his wife without saying goodbye. Calli appears and looks extremely distraught. She goes straight for help. Whatever she has seen and experienced has scared her out of her muteness.

While most of the adults are relieved and encouraged to seek Calli, Martin reacts differently. He immediately sees what is in her hand, and it fills him with fear. When she speaks, her single word causes the strong man to crumble.

As the reader sees the scene of the child coming out of the woods from Antonia's perspective, it almost seems as if she's describing a piece of art. All the horrible aspects of the situation seemed to disappear as the mother embraces her daughter and listens to her speak after the years of silence.

The horror of the day isn't over yet. Calli runs harder than she has before in order to get help. She wants to save her brother, she wants to help her friends, and she is also scared because she feels as if someone is watching her. She ignored her mother's outstretched arms because she is so desperate to get help, and she uses her voice for the first time in years. After stating her brother's name, she lapses back into silence.

Martin was surprised to hear Ben's name come out of Calli's mouth. He tries to get information on his daughter as he fights back jealousy. This girl is safe, but his is still missing. When he sees his daughter's underwear in the police car, it propels him into motion. He isn't waiting around for protocol or anything else. Even though he's not familiar with the words, he's on his way to go rescue the girl.

Louis knows that there is nothing that he can do to hold Martin back at this point. In an attempt to keep the man safe, he joins him. While calling for backup, he warns Martin that the situation is going to be tough when they get to the top, and his own safety is in jeopardy. He tries to remind Martin that he is trained in this type of matter

and Martin needs to respect protocol. Martin is moving ahead with an unnatural strength. All he wants to do is get to the top to help his daughter.

Everyone knows that Griff has a bad temper, and Martin and his wife had not excluded him as a suspect. Ironically, it's Martin's temper that sends Calli off into her mother's



arms for protection. Calli is excited that she communicated, and she is amazed that nothing horrible happened when she spoke. This implies that she did something or someone said something at some point that made her think that she would come to harm if she spoke. That said, she realizes that she should have said more. She is exhausted after all she has been through and doesn't say more. Her mother is now her safe spot, and she sleeps.

When Ben hears noises he is worried that his father has come back to kill him. Still, he is dedicated to protecting Petra so he stands firm. In this section, the reader sees how he is ready to face opposition like a man, but he is still very much a young boy. Throughout the novel, Louis has been dealing very professionally with the case. He shows flexibility in decision-making as he deals with the repercussions of individual choices such as Martin rushing up the mountain. He stays with Martin to keep him safe, but he doesn't lose track of his professionalism, and he calls for help so that now, at the top of the bluff, a helicopter is coming in to help Petra.

Antonia regularly shows that her biggest passion in life is her children. She is torn between the two now, and once again the reader is reminded of her faith in Louis as she goes off with Calli, trusting that Louis will take care of them. This trip to the hospital can benefit Calli in more ways than one. Not only will they be be assured that she is all right, but medical personnel might also be able to assist her with her speaking. During this section, Antonia finally realizes that her husband is not out fishing. It's obvious that this comes as a shock to her. During the examination, Antonia is there to support her daughter even when it is unpleasant. She has been doing her best to avoid the realization of how traumatic the experience might have been for Calli, and she gives voice to her insecurities for the first time during the section.

The search is over for Martin, but Louis knows that his job is just beginning. He still needs to get Ben and Martin down the bluff safely, and he knows that there is a perpetrator on the loose. He notices something unusual in the trees, but he is compassionate and doesn't share this observation with the others. He just makes a mental note to go back and check it out. When he sends Ben off to his mother, he treats the boy in a fatherly manner.

Martin is flirting with shock. He isn't sure how he ended out on a four-wheeler after letting his daughter go. Everything is overwhelming. Although his daughter is damaged, he is very happy that she is still alive. He takes on the role of protector, knowing that his wife will play the role of a comforter. This mild-mannered man has turned a corner as he makes plans to go out to find the perpetrator and kill him.

Calli is finally getting some peace. She gets to rest, and her bruises and cuts are tended. Mother comforts her as she used to comfort her in the past with the story of her own birth. It makes her happy because her mother deliberately leaves out the harsh aspects of the story. The tranquility of the scene suddenly changes as Calli looks terrified. She is looking at her brother, and it's unclear to the reader and those in the room whether she is horrified because he reminds her of the traumatic situation or if it's because he looks so beaten up. In their attempt to protect her, the ones caring for her



lose out on some vital information as they give her a sedative, and she falls asleep before she can communicate what she is thinking.

Martin goes home and tells his wife what has happened, but he leaves out all the horrible details. He just says that she is needed over at the hospital so that she can be there to help their daughter. He asks if she can handle it alone, and his wife doesn't question she deeply. It's almost as if she doesn't really want to know what he is up to. Mrs. McIntire, who has been in this situation before, has insight into what he is doing. They leave, and he reaches for a gun he barely knows how to use.

She also likes being with her father, but only when he is sober. When he has too much beer, he is mean, and she is scared of him. Calli is a bright girl, and although she won't talk, and she has accidents regularly, she is able to hold her own in classwork. The teachers teach her some basic sign language so she can communicate when she has to go to the bathroom. Calli is very good friends with Petra. They play with their dolls together, and Petra always seems to know what Calli needs. Calli has a treasure box in her room and it contains elements of nature it, including some fluff to make wishes on.

Petra

Petra is a seven-year-old girl with a big heart. Everyone loves her wherever she goes. Her mother desperately wanted to have children and at first it didn't seem like she would have any. Petra was born years later and her father is an older father. She is considered a treasure and a blessing in their household. Her father is a professor, and he takes her to work where she creates drawings for others and makes them smile. She comes up with a job idea for a student who is concerned about finances. Petra is very close to Calli, and she is able ago communicate with her friend at a level where words aren't necessary. Petra's parents are protective of her and don't let her go off into the woods on her own. When she is in trouble, she calls for her mother.

Martin

This character is Petra's father. He is a professor who had a child when he was older. He is very conscious of his role as a family protector.



Fielda

This character is Petra's mother. She was desperate to have a child and overdosed once when she thought she wasn't going to shave a child. She is the nurturer in the family.

Griff

This character is Calli's father. He is gone weeks at a time as he works in Alaska. He drinks too much beer and becomes abusive, beating on his family.

Ben

This character is Calli's brother. He is close to Calli and tries to protect her. most of the time, he is kind and even-tempered, but he loses control and lashes out when people make fun of the ones he loves.

Roger

This character is the best friend of Calli's father. They were supposed to be off fishing together when the girls disappeared.

Lucky

This character is a student that Martin's family befriends. He plays with the girls and joins in family celebrations.

Jenn McIntire

This is a 10-year-old girl who was abducted and found dead in Ayer before these girls went missing.

Mary Ellen McIntire

This character is the mother of a girl who was taken from her home and murdered a year before Calli and Petra were discovered missing. She wants to help in the investigation any way she can.



Objects/Places

Pink Nightgown

This is what Calli was wearing when she disappeared.

Cowboy Boots

Calli loved wearing these shoes. She got them from her brother after tormenting him for them.

Gun

This is what Martin grabbed when he went out to find his daughter's attacker.

Antonia's Garden

This is an area where Antonia works to stay calm. It's where she discovers footprints that help in the investigation.

Journals

Mr. Wilson reaches Calli better than other counselors when her encourages her to use these instead of talking.

Willow Creek Woods

This is where Calli, Antonia and Ben like to go and play and have picnics.

Iowa City

This is where Petra is taken for treatment.

Necklace

This is an object that Calli has in her hand when she comes out of the woods. Petra was never without it.



St. Gilianus

This is where Martin worked as an economics professor.

Mourning Glory

This is where Fielda worked as a waitress when Martin first met her.

American Sign Language

Calli learned basic words in this so she could communicate with her teachers.

Beer

This is what Griff drank in excess. It turned him violent.



Themes

Relationships

In the case of missing, young girls and the ensuing investigation, relationships are critical. Kelly and Petra had a unique relationship in which they could get along with each other, play, and communicate without words. They both disappear at the same time, causing people to wonder whether they ran off together. In the past, Petra has always been there to help Calli. Calli's mother pointed out to her daughter that someday Petra would need her, and she should be ready to help her friend. This becomes very true when Petra is in trouble in this story. Calli has to go out of her element to save her friend.

The relationship between the deputy sheriff and Antonia also becomes a big part of the book. The former sweethearts are still drawn to each other, causing jealousy and anger in their spouses. This affects the investigation both positively and negatively. It's positive because Louis knows what Antonia is thinking and how she'd react to certain situations, but it's negative because it brings out the worst in Griff.

Relationships between friends and family are also important to the story. Antonia is left without many friends because most children don't want to play with a mute girl, and she doesn't want to invite anyone to her home where they might discover how mean Griff is.

The Martins are very friendly. Fielda's mother is there as a resource for them and they open their home to others. This is shown in the way they invite Lucky to family events and celebrations, even getting him a job with family members.

Abandonment

There are two types of abandonment that are highlighted in this book, and both are essential to the story. From the beginning of the book, the reader understands that Griff has become a parent that his family doesn't want to be around. He scares them and treats them horribly. He lashes out at them both mentally and physically. They're happy when he leaves to go off to his job in Alaska.

When he is around, they never know what he is going to do. He is fine - even loving and nice - when he has not been drinking, but once he starts drinking beer, then his personality becomes nasty, and he lashes out at them physically and mentally. When Antonia fell in love with him, it wasn't a problem. Over the years he began to drink more, and he lashed out more. He abandoned his family to pursue alcohol.

Deputy Sheriff Louis wasn't an alcoholic like Griff, but he too abandoned his own family. Everyone in town knows about the close relationship between Louis and Antonia. Although they aren't lovers, they are still mentally quite connected to each other. Louis



is constantly reprimanded by Christina for ignoring the needs of his wife and son in order to help Antonia. She eventually leaves him because she feels so abandoned.

Parenting Guilt

Antonia is consumed with guilt as she thinks of her parenting style. When her daughter goes missing, she thinks back on the years and is horrified by the fact that she kept her children in a dangerous situation. Martin and his wife accuse her for allowing Riff to be close to the girls when they suspect him of harming their child. Although Antonia feels horrible about her parenting, evidence shows that she is a wonderful mother. She is constantly caring for and nurturing her children. They come to her for comfort, and they appreciate the time that she spends with them playing in the woods.

Martin and Fields both feel that they have let their daughter down, too. Martin, especially, feels as if he let his daughter down by letting her get taken out of the house during the night. Both families feel judged by the general public when their children go missing. They feel as if the public is holding them personally responsible for neglecting their children to a point where they disappear during the night.

The two families are very different in their approach to parenthood, but they find common ground in the guilt that they feel when their daughters go missing. When Antonia talks with Martin near the end of the novel, they are able to express how they really feel about the situation and instead of blaming each other, they become friends.



Style

Point of View

One of the interesting aspects of this book is that it is written from many points of view. This sections that highlight Antonia's point-of-view are written in the first person in present tense. The sections in Calli's point of view are written in the third-person omniscient in the past tense. Even though it is the third person, her sections also delve into her thought processes. The sections from Petra's point of view are written in the first-person present tense. When Martin gets his point of view, it's in the first-person present tense even though it frequently covers events that have already taken place. However, when Ben's point of view is given, it is in past tense and he talks directly to the missing Calli. The sections with Deputy Sheriff Louis' point of view are also written in the first-person present tense.

Since the book is written using the points of view from so many people, the reader is given a clear and rounded picture of exactly what is going on. The reader knows what has happened to each of the girls before the police uncover their whereabouts.

Setting

This novel takes place in a small town in Iowa. This is important because it is a remote community where everybody knows each other. Crime is minimal, but it is beginning to creep into the area. The small-town atmosphere has kept Antonia from meeting people and developing friendships because she is concerned about what everybody will think about her husband. The sheriff department is small but efficient. Since it isn't a big city organization, they are able to bend the rules a bit. For example, Louis brings in help based on his own intuition rather than actual evidence, and his co-workers support him.

The novel takes place in the edge of a woods, which is also important. It makes the investigation all the more difficult. It also adds depth to the story showing that a setting that can be imaginative and magical can also become the setting for a child's (and parent's) worst nightmare.

Language and Meaning

This book is written from the point of view of many different characters. However, the language structure never varies. The author does not use unique voices for each character. The vocabulary for the older, educated father is very similar to the language used by the 7-year-old girls as well as the course, drunken father. The book flows well and is easy to read. There are interesting vocabulary words thrown into common sentences, which make the reading more interesting. For example, instead of stating that a character woke up with bed-head, the author wrote "my bed-mussed hair."



Structure

This novel is broken up into many sections. It has a cover followed by reviews claiming how wonderful the book is. These reviews are followed by the title page, a dedication page, then a page with a quote. A table of contents show the order of sections in the book. There are 82 sections including a prologue and an epilogue. These sections vary in length - some are extremely short while others go on for many pages. The epilogue is followed by a page of acknowledgments then a section of questions for discussion.
